

On the 3rd august 2006 it was two years since the LOCAL AUTHORITIES of BAMERG divided a nine year old child - the boy AENEAS from his mother.

The indictment: 'Münchhausen-by-proxy-Syndrom (MbpS)'. And as it proved it was illegal and unlawful. Based on a supposition.

They transported the mother under police supervision to the Psychiatric Clinic of Bamberg. After 30 hours they had to release her as the judge of the guardianship court could not maintain the accusation. (This letter is enclosed)

At the same time, when they arrested the mother PETRA HELLER they transported the child to Erlangen into the "KLINIK MIT POLIKLINIK - for kids and youth people" to the Prof. Dr. Rascher. They allowed his grandaunt to accompany him - but when they arrived in the Clinic they send her home. Prof. Dr. Rascher had to give a medical certificate.

Some months, a long time for a child, he was living (housed or arrested?) in this clinic - the family was not allowed to visit him. And so till now - only the grandaunt can visit him since this year. Letters to AENEAS returned - objection: they ordered to change or remove some words, 'we are in waiting of your return to celebrate together your birthday' - The LOCAL YOUTH AUTHORITIES FEARED PSYCHICAL INURIES!

Proved is that PETRA HELLER and her son AENEAS are suffering of the LYME DISEASE (= BORRELIOSE) since years. The medical treatment they got by physicians (conceded experts!), the method of curing was a longtime therapy and showed recovery.

But the LOCAL AUTHORITIES didn't want to hear the experts nor read the results. They didn't know that the "inventor" of the disputed 'MÜNCHHAUSEN-BY-PROXY-SYNDROM' (MbpS) Prof. Sir Roy Meadow (GB) was accused of professional misjudgement and the verdict was guilty. He lost his approbation and his name was expunged of the list of the medical experts of the courts of law.

In the passed two years the local AUTHORITIES and the JUDGE of the court of law didn't nothing to rehabilitate the mother of AENEAS. Therefore the mother PETRA HELLER accused the two judges of the court of law. One of them, JUDGE HERBST, promised in a broadcast intervies (Bayer. Rundfunk B 5) on the 7th august 2005 to adjudicate upon this case in the next two or three weeks - nothing happened!

The mother and her family are despaired. Friends of them inform on internet on

www.petra-heller-info about this scandal.

There you can read the truth - there are the letters of the local authoroties and their incapacity, of their lies and also how their friends, unknown people, physicians, scientists and medias 6from al over the world) acted and appealed against the accusation of MbpS.

There are statements who disproved the misinterpretations of the judges. These persons acted inexcusable, they were reduced to conjectures of the local authorities like YOUTH WELFARE, SOCIAL- and MEDICAL BOARDS! They did not investigate!

As outsider can see, there are some medical scientists in Germany and all over the world who investigated and are informed. They informed in the media the public that the 'MbpS' is 'questionable - is an exciting suspicion.'

The AUTHORITIES here in BAMBERG had the chance to get informed. On July 2nd, there was a SYMPOSIUM about 'MbpS' - Lyme diseases and legal procedures - medical judicial investigation. (annexed paper) -

... they are victims of official obstinate persons in a prestige fight of physicians and experts (!) here in Bamberg and Erlangen and of local authorities who are representing the profile of their strong position in jurisdiction. And they don't want to loose it!!

There are a lot of papers, letters, they made declarations and had best evidences - good people made demonstrations, every second saturday in front of the ancient townhall an the bridge (cover page Bamberg World Heritage) Reports on TV...

What can we do else to help AENEAS and his mother PETRA HELLER?

Some people told us to inform important (VIP) PERSONS and INSTITUTIONS in Europe and from abroad.

So we implore you. Please help AENEAS and his mother.

You can intercede for them and request the

COMMISSIONER of the RIGHT of MAN (MENSCHENRECHTE)
